Sale Process

- The Woods Golf Club is being sold pursuant to Chapter 128 of the Wisconsin Statutes pending in the Circuit Court for Brown County, Wisconsin, Case No. 12-CV-522
- Bids are due to broker by Friday, June 22, 2012, at 5pm
 - All bids must be submitted on the Receiver's Asset Purchase Agreement form, available from broker
 - The highest bidder will be required to make an earnest money deposit of \$50,000
- Receiver is obligated to take the highest offer and will diligently work to secure a hearing for Court approval of the Sale Order
- Winning bidder will complete due diligence and waive contingencies prior to the Court hearing date
- Until the Court has approved the sale, Receiver retains the right to continue to market the property and to negotiate and accept offers from other parties
- Closing will occur within five business days of the Court approving the sale and entering the Sale Order in the Chapter 128 Proceeding




